Advertising Contract Terms & Conditions:

- This agreement shall be for a minimum term of one month from the effective date hereof and is renewable for one-month terms by Sun City Grand Community Association by use of this written contract only.
- Advertiser agrees to comply with all of the Association's time deadlines for delivery of the services throughout the term of this agreement. The Association may terminate all or any portion of the services by providing thirty days' written notice to the Advertiser.
- All advertisements' must be contracted with the Activities Office by the first day of the month prior to the month advertising is to begin, unless the first day falls on a weekend, when the deadline will be the previous Friday.
- Prices are effective September 1, 2008 and are subject to change without notice.
- All payments are final. Orders must be paid in full at the signing of the contract with cash, personal or cashiers check or money order. Make check payable to Sun City Grand CAM and submit with the completed contract and camera-ready artwork; contract must accompany payment.
- This agreement is subject to approval by an authorized representative of the Sun City Grand Community Association, Inc. prior to publication and will be cancelled with all monies returned if advertisement is not approved.
- All ads must be submitted in one of the following electronic file formats: high resolution .pdf, .eps, .5ff or .jpg (high resolution = 300 dpi), or camera-ready on photo paper.
- The Association will decide where to place the advertisement within the Grand Times; however, if the Advertiser wants full color or a specific location the Association will levy a 20% Premium Placement fee on top of the total contract amount.
